WATER QUALITY REPORT

OUR DRINKING WATER MEETS OR EXCEEDS ALL FEDERAL (EPA) DRINKING WATER REQUIREMENTS

This report is a summary of water quality information for 2020. The analysis was made by using the data from the most recent U.S. Environmental Protection Agency (EPA) required tests and is presented in the attached page. As evidenced by the Water Quality Table attached to this page, you can see that AWSC had no violations in contaminant level or water quality standards. AWSC is recognized by the state as a “Superior Public Water System”, and our continuing goal is to not only meet but to exceed all water quality standards as set by state and federal standards. We hope this information helps you become more knowledgeable about what’s in your drinking water.

WATER SOURCES

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals, and in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water before treatment include:

Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.

Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also, come from gas stations, urban storm water runoff, and septic systems.

Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

WHERE DO WE GET OUR DRINKING WATER?

Our drinking water is obtained from GROUND water sources (wells) Trinity Aquifer, and from treated surface water purchased from the Upper Trinity Regional Water District. A Source Water Susceptibility Assessment for your drinking water sources is currently being updated by the Texas Commission on Environmental Quality. This information describes the susceptibility and types of constituents that may come into contact with your drinking water source based on human activities and natural conditions. The information contained in the assessment allows us to focus source water protection strategies. ALL DRINKING WATER MAY CONTAIN CONTAMINANTS.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health. When drinking water meets federal standards there may not be any health based benefits to purchasing bottled water or point of use devices. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. SPECIAL NOTICE

You may be more vulnerable than the general population to certain microbial contaminants, such as Cryptosporidium, in drinking water. Infants, some elderly or immune-compromised such as those undergoing chemotherapy for cancer; those who have undergone organ transplants; those who are undergoing treatment with steroids; and people with HIV/AIDS or other immune system disorders can be particularly at risk for infections. The Texas Commission on Environmental Quality completed an assessment of your source water and results indicate that some of our sources are susceptible to certain contaminants. Additional Health Information for Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. This water supply is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your tap, you may wish to have your water tested. TURBIDITY

Turbidity has no health effects. However, turbidity can interfere with disinfection and provide a medium for microbial growth. Turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses, and parasites that can cause symptoms such as nausea, cramps, diarrhea and associated headaches.

TOTAL COLIFORM

Coliforms are bacteria that are naturally present in the environment and are used as an indicator that other, potentially-harmful, bacteria may be present. Coliforms were found in more samples than allowed and this was a warning of potential problems.

MAXIMUM CONTAMINANT LEVEL (MCL) - THE HIGHEST PERMISSIBLE LEVEL OF A CONTAMINANT IN DRINKING WATER. MCLs ARE SET AS CLOSE TO THE MCLGs AS FEASIBLE USING THE BEST AVAILABLE TREATMENT TECHNOLOGY

MAXIMUM CONTAMINANT LEVEL GOAL (MCLG) - THE LEVEL OF A CONTAMINANT IN DRINKING WATER BELOW WHICH THERE IS NO KNOWN OR EXPECTED HEALTH RISK MCLGs ALLOW FOR A MARGIN OF SAFETY.

TREATMENT TECHNIQUE (TT) - A REQUIRED PROCESS INTENDED TO REDUCE THE LEVEL OF A CONTAMINANT IN DRINKING WATER.

ACTION LEVEL (AL) - THE CONCENTRATION OF A CONTAMINANT WHICH, IF EXCEEDED, TRIGGERS TREATMENT OR OTHER REQUIREMENTS WHICH A WATER SYSTEM MUST FOLLOW.

pCi/L - PICOCURIES PER LITER (A MEASURE OF RADIOACTIVITY)

NTU - NEPHELOMETRIC TURBIDITY UNITS. THIS IS THE UNIT USED TO MEASURE WATER TURBIDITY.

MFL - MILLION FIBERS PER LITER (A MEASURE OF ASBESTOS)
